Any person, registered business or company involved in a trading relationship as a product and / or services supplier to the retailer sector of the bicycle industry may apply for membership. Must have an Australian Business Number (ABN) or Australian Company Number (ACN)

Membership fee: \$2,000 + GST \$200 = \$2,200

#### 2. Overseas Member

A company not registered in Australian, supplying bicycle products to the wholesale or retail sectors of the bicycle industry in Australia. Must be registered company in country of origin.

Membership fee: \$2,200 + GST \$220 = \$2,420

#### 3. Retail Membership

Any person, registered business or company whose primary business is the retail of bicycles or bicycle related products to the public. Must have an Australian Business Number (ABN) or Australian Company Number (ACN)

Membership fee: \$100 + GST \$10 = \$110 (primary store)  
\$50 + GST \$5 = \$55 (each subsequent store)
